will be sexually abused before reaching their eighteenth birthday. One agency in Dallas County provides a coordinated, multi-disciplinary approach to the investigation and treatment of child abuse cases.

The Dallas Children's Advocacy Center **provided hope and healing to 2,740 children** and non-offending family members during the 2008 fiscal year.

The mission of the Dallas Children's Advocacy Center is to improve the lives of abused children in Dallas County and provide national leadership on child abuse issues.

Data published in this report reflects organizational activity for fiscal year 2008: January 1, 2008 – December 31, 2008.

CHAIRMAN'S LETTER

We can all agree on this: child abuse is intolerable; yet, reality tells us that Dallas County reported over 20,000 alleged cases of child abuse in our community alone in 2008 (as reported by the Texas Department of Family and Child Protective Services). In 2008, the Dallas Children's Advocacy Center experienced yet another year of record-breaking growth for all of its programs, serving the largest number of children in DCAC's history (a 27% increase in the number of children served when compared to 2007). With its coordinated and multi-disciplinary approach to these complicated and delicate cases of abuse, the experts at DCAC have established an enduring and recognizable name as the leader in their field. The Dallas Children's Advocacy Center gives each child victim a new chance at life—a life without the perpetrator, one filled with hope and the chance for a brighter future. After all, that is what every child needs and deserves.

In order to continue to provide critical education as well as accommodate the growing need for DCAC services and the additional staff in which it will require, it is imperative that DCAC leaves the old Victorian home on Swiss to move into a new facility—one which will have the capacity to reach the increasing number of children in need of DCAC's life-changing programs. DCAC purchased land in March of 2008 while also finalizing their plans for the new building soon thereafter. All of us can attest to the fact that the economy presents a significant challenge to DCAC's Capital Campaign; yet, DCAC and its supporters are determined to continue its goal to move into a new facility amidst

this challenge as the children in our community can no longer be denied the critical services and treatment they so desperately need. Moreover, your support and backing have never been more crucial and needed than they are now.

As parents and as advocates for children, we must take a stand for the safety of our children by supporting the experts at the DCAC—those who work tirelessly each day to combat and prevent crimes against children. I want to sincerely thank you for your continual and vital support of this phenomenal organization. I look forward to walking with you through this exciting new time of transition at the Dallas Children's Advocacy Center as we partner with this agency to keep our children safe from those who work to harm them.





Sophie*, a nine year old girl, was removed from her parents' custody after her brother was murdered. In the beginning, she spent most of her therapy sessions in tears or facing the wall. Her therapist invited Molly, a DCAC therapy dog, to join the sessions with the hope of providing comfort to Sophie as she begins to process the tragedy that had occurred. During her first session with Molly, Sophie was told about the dog's history which is very similar to her own. Molly was adopted

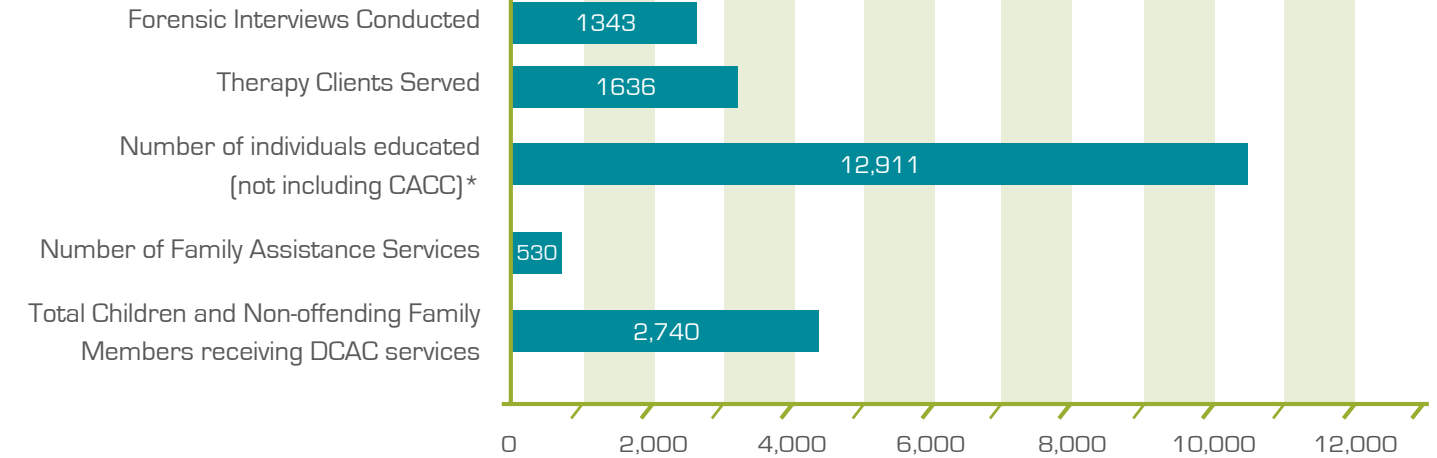
by her handler after an abusive past, and Molly's brother also died due to neglect. A special connection between the small girl and the dog formed causing an obvious breakthrough for Sophie. This connection was the first step to hope and healing for Sophie. Although she was still reluctant to share her feelings, she seemed to find comfort in knowing she was not alone. She was able to relate to Molly when she could not relate to the rest of us.

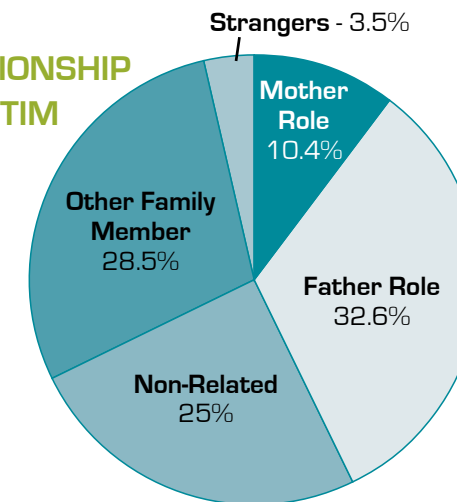

21 therapy dogs and their handlers provided **492** volunteer hours - breaking emotional barriers, enabling courage, and soothing the children through animal assisted therapy.

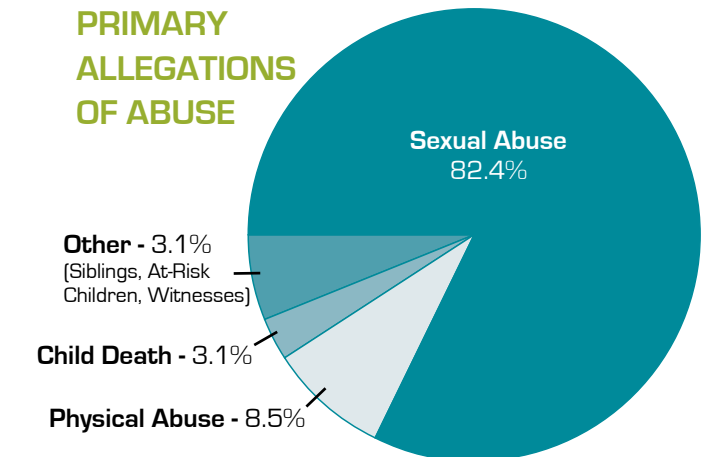
PRIMARY SERVICES

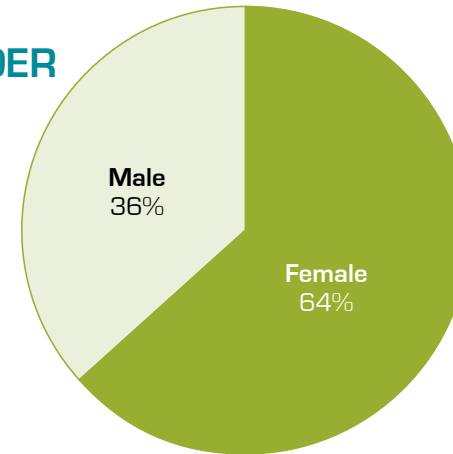

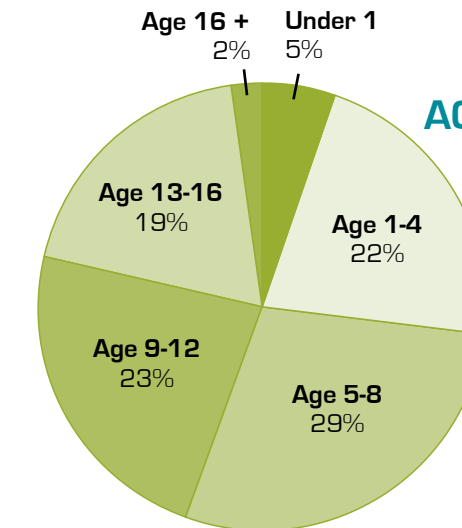


Child Client Demographics

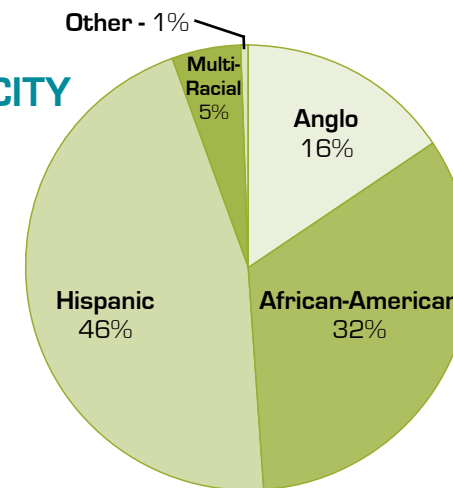

Forensic Interview Program

PROGRAM GOAL

To ensure a coordinated approach to the investigation, prosecution, and treatment of child abuse cases in Dallas County by providing forensic interviews to abused children referred to DCAC by police or CPS caseworkers.

- DCAC's specially trained Forensic Interviewers assist Dallas County law enforcement detectives by conducting developmentally and age appropriate investigative interviews based on a nationally recognized protocol.
- These interviews are witnessed by the parties involved in the investigation (law enforcement, CPS, and assigned Assistant District Attorney) and are fundamental to the successful investigation of child abuse cases.
- Interviewers employ a nationally recognized protocol to effectively interview child abuse victims. This investigative protocol includes: building rapport, identifying anatomy, inquiring about touch, describing the abuse scenario, and closure.

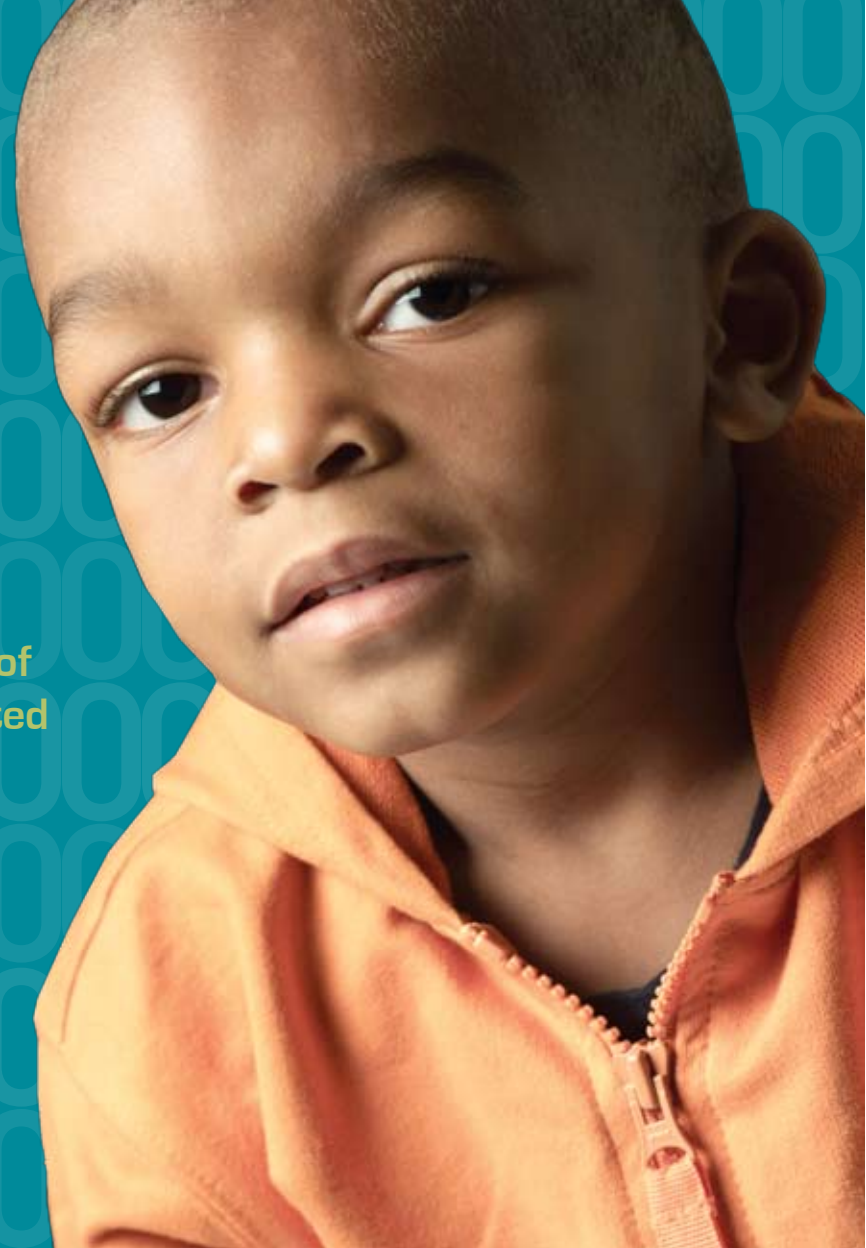

Education

PROGRAM GOAL

To increase the number of parents and professionals (both within our community and nationwide) educated on child abuse topics.

The DCAC Education program provided education on a number of topics including: recognizing and reporting child abuse, Internet safety, and personal safety for children.

DCAC created and produced a 24 minute parent education video, "Keeping Your Children Safe from Harm". 3000 copies of this video have been disseminated within the community. Individuals who watched the video and completed a pre- and post- test have a 28% increase in knowledge on child abuse issues.

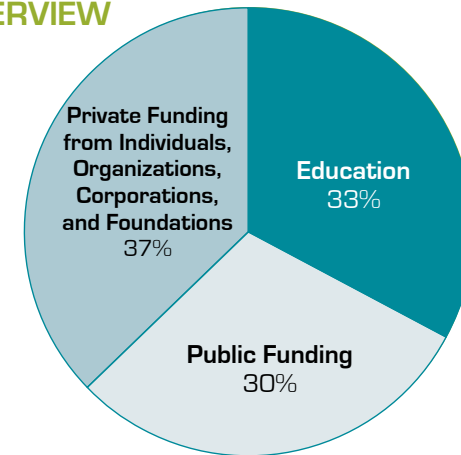
